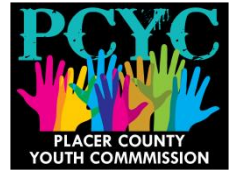




PLACER COUNTY BOARD OF SUPERVISORS

APPLICATION FOR APPOINTMENT TO 2019-20 PLACER COUNTY YOUTH COMMISSION



THE FOLLOWING IS PUBLIC INFORMATION

BACKGROUND

The Placer County Youth Commission is an Advisory Board to the Board of Supervisors, dedicated to promoting the youth voice in local government and decision-making. Founded in 2009, the Youth Commission is made up of eighteen youth of diverse backgrounds who care about the Placer County community and have a drive to make our community the best possible place for youth. Members are supported by an adult advisor from Placer County Health and Human Services.

BENEFITS OF BEING A YOUTH COMMISSIONER

- Learn about the local government process first hand.
- Learn how to make change in your community through the existing government.
- Play an active role in improving the services, programs, and opportunities provided for youth in the county.
- Be a leader in your community working to create positive change.
- Gain valuable skills in community organizing.
- Gain experience and skills that will be beneficial to you in college or the workplace.
- Have fun and meet new friends.

ELIGIBILITY

- Placer County residents between 14 (or entering 9th grade) to 21 years of age.
- Commissioners will need to commit to a one-year term from July 1, 2019 through June 30, 2020.
- An individual may sit for a maximum of four terms, except that anyone who turns 22 years of age during their term may not be re-appointed.
- Membership shall consist of at least one representative from each of the five supervisory districts in Placer County.

APPLICATION PROCESS

1. Complete and submit application by June 1st, 2019.
2. Applicants under consideration for a position will receive an interview with the nominating committee composed of the Adult Advisors, youth from the community, and/or adult(s) from supporting community agencies. Interviews will occur in mid to late June, 2019. (Please contact us if earlier interview needed)
3. The Commission will recommend new members to the Placer County Board of Supervisors who then make the appointments in July.
4. You will be notified of decisions by the end of July, 2019.

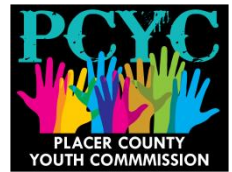
TIME COMMITMENTS & RESPONSIBILITIES

1. **Trainings:** Trainings will occur in late August. Dates and times to be determined. Training focuses on getting to know your fellow Commissioners, roles and responsibilities, community research, creating community change, and parliamentary procedure.
2. **Meetings:** There are two meetings a month (August-May): First meeting is generally held on the 1st Wednesday of each month from 6:00-8:00pm in the Board of Supervisors Chambers (Auburn) and the second meeting held at a time and date to be determined upon appointment of the *Commissioners (generally will be the 3rd Wed. of the month at the Rocklin Library or Rocklin PD)*.
3. **Subcommittees:** Each Commissioner is required to serve on one subcommittee. These committees work on special projects, events, and activities related to their area of interest.
4. **Special Events & Fundraisers:** All Commissioners are expected to actively participate in all special events and fundraisers that the Youth Commission supports or offers.
5. **General Behavior:** Commissioners are expected to maintain a high level of behavior and citizenship in school and in the community. Commissioners represent Placer County and should behave accordingly.
